**Oil or Gas Appliances, Heating, Air Conditioning, Refrigeration and Ventilation Systems**

- A. The permit fee for each oil or gas burning appliance shall be \$20.00 except that a \$30.00 minimum fee shall be required if less than two appliances are being inspected.
- B. The permit fee for each oil or gas burning furnace or boiler, including appurtenances attached thereto (where each dwelling unit has an individual system) shall be \$35.00.
- C. The permit fee for each air conditioning and refrigeration unit (where each dwelling unit has an individual system) shall be \$30.00 per unit.
- D. Steam, warm air or hot water heating systems (where each dwelling unit has an individual system) shall be \$35.00 for each such system.
- E. The permit fee for the installation of commercial, industrial, or institutional Heating, Ventilation and Air Conditioning equipment shall be one and one-half percent (1.5%) of the total market value of the installation.

**Plumbing**

- A. For the installation of plumbing fixtures, devices and connection, the permit charge shall be \$25.00 for the base permit fee plus \$10.00 for each plumbing fixture, device or connection to the sewer or plumbing system.
- B. For any alteration, repair or extension to an existing plumbing system, where the work is of such a nature that the permit fee charge cannot be determined from the above schedule, the permit fee charge shall be \$35.00 for the first \$500.00 or fraction thereof, plus \$10.00 for each additional \$500.00 or fraction thereof of the total market value of such alteration, repair or extension.

**Grading, Excavation**

- E. 10,001 to 100,000 cubic yards \$325.00 for the first 10,000 cubic yards plus \$66.00 for each additional 10,000 cubic yards or fraction thereof
- F. 100,001 cubic yard or more \$919.00 for the first 100,000 cubic yards plus \$36.50 for each additional 10,000 cubic yards or fraction thereof

**Demolition of Buildings**

**Plan Review Fee**

65% of Building Permit Fee except for residential projects requiring plan review that do not exceed \$15,000 valuation

**Electric**

- A. Minimum fee for each separate inspection of an installation, replacement, alteration or repair is limited to one inspection only: \$35.00

- B. Services, changes of service, temporary services, additions, alterations or repairs on either primary or secondary services shall be computed separately:

- 0 to 300 amp ampere capacity \$50.00
- 101 to and including 200 ampere capacity \$50.00
- 400 amp \$58.00
- For each additional 100 ampere capacity or fraction thereof \$14.00

- C. Circuits, installation of additions, alterations, or repairs of each circuit or sub-feeder shall be computed separately, including circuits fed from sub-feeders and including the equipment served, except as provided for in (D) through (K):

- 0 to and including 30 ampere capacity \$ 8.00
- 31 to and including 100 ampere capacity \$10.00
- For each additional 100 ampere capacity or fraction thereof \$ 5.00

- D.** Maximum fee for single-family dwelling shall not exceed \$150.00 if not over 300-ampere capacity. This includes service, feeders, circuits, fixtures and equipment. The maximum fee provides for not more than two rough-in inspections and the final inspection per dwelling. Additional inspections are at the re-inspection rate.
- E.** Maximum fee on an apartment building shall not exceed \$70.00 per dwelling unit. A two-unit dwelling (duplex) maximum fee per unit as per single-family dwelling.
- F.** The maximum number of 0 to 30 ampere circuits to be paid on any one athletic field lighting standard is ten.
- G.** In addition to the above fees:
- 1) A charge of \$3.00 will be made for each street lighting standard.
  - 2) A charge of \$4.00 will be made for each traffic signal standard. Circuits originating within the standard will not be used when computing fees.
- H.** In addition to the above fees, all transformers and generators for light, heat and power shall be computed separately at \$8.00 plus \$.40 per KVA up to and including 100 KVA. 101 KVA and over at \$.30 per KVA. The maximum fee for any transformer or generator in this category is \$80.00.
- I.** In addition to the above fees, all transformers for signs and outline lighting shall be computed at \$8.00 for the first 500 VA or fraction thereof per unit, plus \$.70 for each additional 100 VA or fraction thereof.
- J.** In addition to the above fees, unless included in the maximum fee filed by the initial installer, remote control, signal circuits and circuits of less than 50 volts shall be computed at \$10.00 per each ten openings or devices of each system plus \$5.00 for each additional ten or fraction thereof.
- K.** In addition to the above fees, the inspection fee for each separate inspection of a swimming pool shall be computed at \$35.00 plus circuits. Reinforcing steel for swimming pools requires a rough-in inspection.
- L.** for the review of plans and specifications of proposed installations, there shall be a minimum fee of \$150.00 up to and including \$30,000 of electrical estimate, plus 1/10 of 1% on any amount in excess of \$30,000 to be paid by persons or firms requesting the review.

- M.** When re-inspection is necessary to determine whether unsafe conditions have been corrected and such conditions are not subject to an appeal pending before any Court, a re-inspection fee of \$35.00 may be assessed in writing by the Inspector.
- N.** For inspections not covered herein, or for requested special inspections or services, the fee shall be \$30.00 per man hour, including travel time, plus \$.25 per mile traveled, plus the reasonable cost of equipment or material consumed. This section is also applicable to inspection of empty conduits and such jobs as determined by the City.
- O.** For inspection of transient projects, including but not limited to, carnivals and circuses, the inspection fees shall be computed as follows:
- Power supply units according to Item “B” of fee schedule. A like fee will be required on power supply units at each engagement during the season, except that a fee of \$25.00 per hour will be charged for additional time spent by the Inspector if the power supply is not ready for inspections as required by law.
- Rides, Devises or Concessions: Shall be inspected at their first appearance of the season and the inspection fee shall be \$27.00 per unit.
- P.** The fee may be doubled if the work starts before the permit is issued.

**License Verification Fees**

- A.** Building Contractors required to be licensed with the State of Minnesota shall be assessed a verification fee of \$5.00 on each building permit issued.
- B.** When verification of a license referenced in 702.010 the contractor shall be assessed a \$5.00 license verification fee.
- C.** When verification of lead certification as required by the State of Minnesota, the contractor shall be assessed a \$5.00 verification fee.
